General Comment:

This is a followup inspection for 693902076 conducted on July 28, 2020. Corrective actions are partially addressed. During this inspection the following compliance issues were observed:

-Additional stabilization is needed to stabilize disturbed soils and in the channel near the entrance to the former well pad, by 12/6/2020. This is a highly erosive area and permanent stormwater controls and erosion controls (seeding and mulching) need to be selected, sized, installed and maintained until long-term stabilization is achieved.

-Weeds need to be controlled no later than 6/1/2021.
