<p>COGCC Inspection Report Summary On Friday 11/13/2020 at approximately 09:50 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the Anadarko Starck 33-18X location #332620 in Weld County, Colorado. While there, I observed incorrect lease name on the battery sign, unused equipment inside and outside of the tank berm, trash at the wellhead and behind the separator berm. During this inspection the following possible compliance issues were observed: Rule 210.b. with a corrective action date of 2/19/2021, Rule 603.f. with a corrective action date of 2/19/2021. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
