Bradenhead gas was routed to combustor from 6/13/19 till 11/20/19, Form 17 on 11/27/19 was 1psi (See COGCC Doc Num 402268653 and attachment). Pressure remained less than the action threshold until 10/25/20. Pressure is now being abated and gas is being re-routed to combustor beginning 11/16/20. 11/16/20 Form 17 79psi, environmental sample obtained at that time (gas only).
