Basis for Review: Action requested was already completed prior to the inspection

Operator Comment: Some level of rutting is normal wear and tear during active snow melt/wet conditions. Location and access road are stabilized unpaved surfaces (graveled and compacted), which are inspected regularly and maintained as needed. An annual environmental inspection is also completed and document every year by environmental staff, and stormwater BMPs are inspected in that process (see file attachment for documentation of this inspection). In August, when the inspection was completed prior to snow, the road was in good condition. It is not feasible to

grade the road during snowmelt or wet conditions, because heavy equipment would further damage the road. The rule citation was not listed on the inspection, but if you are referring to 'Vehicle tracking control practices to control potential sediment discharges from operational roads, well pads, and other unpaved surfaces. Practices include road and pad design and maintenance to minimize rutting and tracking, controlling site access, street sweeping or scraping, tracking pads, wash racks, education, or other sediment controls', we believe we have met the intent of this rule.
