PDC is formally requesting a 45 day extension for the COA on the 19S (#402502368) to provide an update by December 1, 2020. PDC is requesting this extension to conduct a review of the location history before PDC purchased the well site.

COGCC understands that this is a historically shared oil and gas location. As such due diligence is needed to determine the responsible party. Operator shall provide an update within 60 days of approval of this form (December 1, 2020). Once a responsible party is identified that Operator shall submit a Form 27 Site Investigation and Remediation Workplan for the investigation and remediation of impacts to groundwater in accordance with Rule 909.c.
