I, Inspector Mike Longworth, conducted an inspection at TEP ROCKY MOUNTAIN LLC, UNOCAL-66S96W 32NWNE, Location ID: 335274 in Garfield County, Colorado.
During this inspection the following possible compliance issues were observed:
Access road and storm water bmps need maintained.
Location and access roadside ditches have dead debris.
Trash around location. Cans, bottles, food packages, paper plate, etc. Piece of unused pipe near wells and another piece of unused pipe by yellow deadman marker.
Diversion ditch is blocked off by rock mining. Storm water and sediment flowing from blocked ditch to well heads then washing over location and riling reclaim area. Ditch along location needs maintained. Road ditches and check dams need maintained. Ruts on roads are creating riling.
A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
