Comment: It was observed in this inspection that the Location does not meet COGCC 1004.c.(2) revegetation requirements; Well location bare and unvegetated. Cut slopes not reclaimed and current bare/exposed soils, slopes require stabilization.

Corrective Action: _____ Date **06/01/2021**

Comply with 1004 rules and conduct additional reclamation on the Location. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.
