1) An ~3" deep gravel road base was added to the access road next to Hwy 64. The new gravel base extends across the width of the access road and extends 165' north of Hwy 64. The inspector was unable to determine if the added gravel will eliminate mud from tracking until Hwy 64. The roads were dry at the time of this inspection.
