On Monday 12/14/20 at approximately 1100, I, Inspector Scott Ramsey, conducted a routine inspection at Grizzly Platzer, at Location # 335127 in Garfield county Colorado.
While there, I observed normal production operations. All meters have been calibrated on location within the past year. Limited storm water inspection due to snow.
During this inspection the following possible compliance issues were observed:
• Location shows signs of lack of stabilization BMP's in some areas (rutting is present) BMP's require maintenance which in turn can lead to tracking
• No evidence of tracking control BMP's
• Debris/unused equipment next to combustor
Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
