Control weeds at the appropriate time, and no later than 11/1/2020. Per CSU extension, control of Russian knapweeds requires a multi-pronged treatment approach as a single control strategy will not likely be sufficient. Areas treated for Russian knapweed should be reseeded with desirable perennial grasses in the fall to compete with the treated knapweed.
Multiple corrective actions have been issued for Russian knapweed infestation at this location. Infestation appears to be spreading. Corrective action is back-dated to previous corrective action date to document duration of non-compliance.
