While there, I observed normal production operations. All meters have been calibrated on location within the past year. Limited storm water inspection due to snow.

During this inspection the following possible compliance issues were observed:

- Lack of stabilization on cut slope next to separators
- No evidence of tracking control BMP's
- Debris in between and in front of separators (piping)

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
