-Control weeds/remove Russian olive trees. Corrective action is backdated to 12/20/2020.

Corrective action to remove the B-listed noxious weed is not addressed. Per onsite conversation with surface owner, a mature vegetative screen is needed, but it does not need to be Russian olives.
