The location has not been reclaimed and equipment remains. There is an area of cement, pipe riser, tank, electric utility, and other supplies and debris. All equipment and debris should have been removed within 3 months of abandonment. There is an area 120'x80' that has no vegetation growth and has not been regraded and leveled. Soils need to be decompacted by cross ripping to 18 inches. All equipment and debris must be removed and the location reclaimed. The corrective action date is set for when final reclamation was required to be completed. Corrective action needs to be performed immediately to obtain compliance.
