Four partially buried produced water vessels will be removed and samples will be collected per COGCC Rule 905b. The Landowner was notified on December 17, 2020 during an onsite meeting with Noble Energy to discuss operational activities on her property. An excavation plan will be reviewed with the Landowner prior to implementation.
