pH and SAR exceedances were present in the top 3 feet of soil. The impacted areas were excavated to a depth of 3 feet, inorganic elevated soils were placed in the adjacent vault from 9 foot to 3 foot below ground surface. Excavated materials for the vault were spread over the excavated impacted area and backfilled to surface providing a 3 foot cover of compliant 910-1 soils.
