After reviewing locations and flowlines you provided, here are recommendations.

Off location flowlines 470455 (Blach 01-08 125-07172), 470457 (Hillman 02-09 125-07171) and 470436 (SOC State 14-36 125-07670) should transfer with their respective end point locations as the wells are now operated, and off location flowlines were registered by Own Resources.

Off location flowlines 457 281 & 457282, we feel should stay under Rosewood Resources due to lines are to a well, Eyestone 07-34, that was PA by Rosewood with a date of 7/31/2018, which is prior to Own Resources acquisition of Rosewood Resources.

API 125-11444 J Brenner 44-32 should transfer but only if Own Resources would not be responsible for NOAV prior to acquisition date.

API 125-11444 has related off location flowline 476833 and in process NOAV 401781675 for MIT compliance in 2018.

I need to ask our hearings enforcement supervisor if I am allowed to transfer 125-11444 because of the NOAV. If not, I would recommend that we delete that well and process the remainder of the Form 10. If both buyer /seller respond to my email I can easily add the off location flowlines to this document.
