Excavation of oily soils within an approximate area of 0.18 acres will be hauled to a landfill that will accept E&P waste. The excavated soils will be replaced with clean fill dirt and topsoils prior to revegetation. Excavation is planned to begin the week of March 29, 2021 and be completed by April 2, 2021. Reclamation will begin the following week on April 5, 2021.

### RECLAMATION PLANNING

Clean topsoil will be hauled in to replace the excavated soil. It will be tilled with the native soils to a depth of eighteen inches below ground surface. An NRCS recommended seed mix will be applied per their recommendations using a no-till drill seeder. Soil amendments will be applied as recommended. After seeding, the area will be stabilized with 2000 pounds of weed free straw mulch crimped into the soil. Pending landowner approval, the reclaimed area will be fenced for approximately 2 years until vegetation is well established. Reclamation activities will commence by April 5, 2021 and be completed by April 9, 2021 pending weather conditions. If weather impacts the dates of soil removal and disposal or reclamation, McElvain will notify the COGCC of changes to the schedule.
