Comment Unmanaged Common mullein in both the rosette and adult stage were observed at the tank battery which is starting to spread onto the adjacent surface owners property. Kochia was also observed.  
  
Puncture vine was observed with the deadman at the well location. Surface owner has been attempting to control but it will be the responsibility of the Operator to manage and control. Refer to the attached inspection photos.

Corrective Action Comply with Rule 1003.e.(1) to control and manage both undesirable species and noxious weeds, which includes managing and controlling Common mullein that has spread onto the adjacent surface owners property.
