 1. MIRU. Pull 2 3/8" tubing.
 2. RU wireline company.
 3. TIH with CIBP. Set BP at 7584'. Top with 2 sxs 15.8#/gal CI G cement. (Top of J-Sand perms @ 7634')
 4. TIH with CIBP. Set BP at 6798'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Niobrara @ 6848')
 5. TIH with casing cutter. Cut 4 1/2" casing @ 2500'. Pull cut casing.
 6. TIH with tubing to 2550'. RU cementing company. Mix and pump 100 sx 15.8#/gal CI G cement down tubing. (Stub plug from 2500'-2300')
 7. Wait a sufficient time to confirm static conditions. If at any time after placing this plug there is evidence of pressure or fluid migration, contact engineering before continuing operations.
 8. Pick up tubing to 1300'. Mix and pump 100 sx 15.8#/gal CI G cement down tubing. (Pierre coverage from 1300'-1100')
 9. Pick up tubing to 666'. Mix and pump 269 sx 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
 10. Cut surface casing 6' below ground level and weld on cap.
