Access road shows signs of lack of stabilization BMP's in some areas (rutting is present). No tracking bmps observed for access road. Storm water bmps are failing at access right away and CR215. Storm water is moving across CR215 and washing away the shoulder on opposite side of road. A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
