Renegade requests approval of alternative MIT for the Bradbury #12-14 as allowed for by Rule 326.b(3) after Director consideration of any equivalent test or combination of tests.
Renegade believes the Bradbury #12-14 demonstrates mechanical integrity due to a 8/22/2019 bradenhead test (Doc #402148719) performed showing no bradenhead pressure and tubing/casing pressure of 0/5 psi coupled with a 4/17/2020 bradenhead test (Doc #402377574) conducted showing no bradenhead pressure and tubing/casing pressure of 0/7 psi. The Bradbury #12-14 has had remedial cementing which has placed cement from 3000' to the surface casing shoe at 432'. If the well lacked integrity old drilling mud would kill this very low pressure/high permeability well and casing pressure would not continue to build. Well pressures including the bradenhead will be monitored monthly to ensure integrity.
This well is SI as a result of the Third Creek Gas Gathering System shutdown on 6/1/2018 and was producing at the time of SI. The Bradbury #12-14 was produced utilizing conventional rod pumping equipment.
