Renegade requests approval of alternative MIT for the Champlin 248 Amoco C#2 as allowed for by Rule 326.b(3) after Director consideration of any equivalent test or combination of tests.
Renegade believes the Champlin 248 Amoco C#2 demonstrates mechanical integrity due to a 12/4/2019 bradenhead test (Doc #402261613) performed showing no bradenhead pressure and tubing/casing pressure of 0/70 psi coupled with a 10/21/2020 bradenhead test (Doc #402524266) conducted showing no bradenhead pressure and tubing/casing pressure of 0/68 psi. The Champlin 248 Amoco C#2 was completed with a SS tool at 1638' and casing gelled with 2000 gallons. If the well lacked integrity old drilling mud would kill the well preventing any formation entry and casing pressure disappear. Well pressures including the bradenhead will be monitored monthly to ensure integrity.
This well is SI as a result of the Third Creek Gas Gathering System shutdown on 6/1/2018 and was producing at the time of SI. The Champlin 248 Amoco C#2 was produced utilizing conventional rod pumping equipment.
