A site investigation will be conducted pursuant to COGCC rule 911 at the Degenhart USX AE 17-99HZ tank battery, well head, produced water vessel, and flowline location. Form 42 and 44 document numbers will be supplied in a subsequent form 27.

Grab confirmation soil samples will be collected from the well head excavation, produced water vessel excavation, beneath the three above ground oil tank, and at the separator. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
