- o The agreement states: 2. "Drillsite. BP shall only use such portions of the Property as are reasonably necessary; however, the surface area actually disturbed for the drill site for both the 160 acre well and the 80 acre well shall be approximately 2.2 acres in total. It is agreed that Landowner shall not use any portion of the drillsite

for any purpose whatsoever. Subject to approval of the Colorado Oil and Gas Conservation Commission ("COGCC"), the drillsite shall be as shown on the plat attached as Exhibit "B". BP shall have the full and complete use of the total drillsite (approximately 2.2 acres) for future operations.
