COMMENTS:

On 1/19/2021, a Form 17 was complete with a beginning pressure of 68 psi and an ending pressure of 1 psi. Gas was present at the beginning of the test, but was not continuous. A gas sample was collected during the Form 17, those results will be submitted once the lab has finished their analysis. Since gas was present at the beginning of the test and the ending pressure was 1 psi, we are electing to plug this well by 7/19/2021. We will continue to monitor and blow down as necessary until the well has been plugged.

Prior to starting bradenhead mitigation, if a sample has not been collected within the last twelve months collect bradenhead and production gas samples for laboratory analysis. Sampling will comply with Operator Guidance - Bradenhead Testing and Reporting Instructions, Appendix A: Liquid and Gas Sampling. Copies of all final laboratory analytical results will be provided to the COGCC within three months of collecting the samples.</p> <p>3. Operator will implement measures to get an initial estimate of the gas flow rate and/or volume from the bradenhead. During the shut-in period record pressure data to adequately characterize the build-up. This mitigation plan may be used for six consecutive months from the date test reported on the Form 17.</p> <p>4. By 7/19/2021 this well must be plugged and a final form 4 bradenhead sundry filed documenting mitigation efforts up until the time of abandonment. The sundry should include details of the sample analysis interpretation, and the flow rate information and pressure data.</p>
