Comment Operator has performed interim reclamation activities to reduce disturbance areas only needed for production operations. However, Scotch thistle, a List B Colorado noxious weed, was observed throughout the northwestern and western interim areas, as well as the western access road that was reclaimed. In the future, Operator shall properly remove noxious weeds. Mature Scotch thistle throughout the interim areas was left in place. Mature seeds could still be viable and only contributing the more weed seeds into the soil seed bank. Refer to the attached inspection photos.

Corrective Action Comply with Rule 1003.f. to properly control and manage Scotch thistle.
 If herbicide treatment is used, Operator shall apply herbicide prior to the late flowering stage (flowering typically occurs from mid-June to September) or seed may still be produced.
