10-3/4" 32.75# Casing was run and cemented at 101'. Cemented with 75 sx. Cement circulated. WOC a total of 6 days and tested casing with 500# pressure for 30 minutes. Test satisfactory.

Mudded up hole at the shoe of surface casing and drilled to total depth with water base caustic-quebracho mud.

A portable drilling mud analyzer was employed to log the mud from the shoe of surface casing to total depth.

A Schlumberger electric log and microlog were run from T.D. to shoe of surface casing.

The well was plugged with 25 sx of cement in the top of the 10-3/4" surface casing and the location was abandoned June 23, 1955.
