Scheid-Cooksey treater was frozen on 2/16/21. Company man began thawing inside treater house with a catalytic heater. The bottom connection of the outside water leg began to drip. Company man immediately called for a vac truck. Vac truck set up & leak became larger. Drain valve was frozen, so vac truck stayed in place sucking up water. Roustabout crew fished out rubber gasket & replaced, then secured the water leg

intergety. AT NO TIME WAS THERE MORE THAN 1 BARREL OF FLUID ON THE GROUND. The treater had a secondary containment berm. Because there was less than 5 bl on the ground at any time this was not a reportable event.

The wet soil was removed and 3/4" road base replaced it. Completed 2/17/2021. Inspector's conclusion that the spill volume was 10 bl is incorrect. At no time was there more than 1 bl of fluid on the ground. It was therefore not a reportable event.

OPERATOR COMMENT AND SUBMITTAL

Comment: Inspector's conclusion that the leak was 10 bl is incorrect. At no time was there more than 1 bl of fluid on the ground and the treater was bermed. Reporting threshold is 5 bl. The leaking gasket was replaced and treater integrity retuned on 2/16/2021. Wet dirt was shoveled out of the treater house and replaced with 3/4" roadbase. The facility is ready to be re-inspected.
