There is heavy Ruderal/Debris weed infestation across location, precluding establishment of desirable vegetation. This site has history of contention with surface Owner as to weed control. Weed establishment appears more extensive since previous 2019 RI Inspection. Alternative controls to herbicide treatments do not appear to have been employed.

Corrective Action

Assess location vegetation once Debris weeds are removed. Conduct any activities necessary as indicated by assessment, (ie: de-compacting, amending, re-seeding/inter-seeding or other) to insure establishment of desirable Vegetation in Interim areas of site. Reclamation activities to be complete by 5/1/21. Adaptive Weed control program for site needs to be developed.
