Comment: It was observed that stormwater and erosion control measures to protect the slopes, and to allow for sediment laden-free stormwater discharge are missing, or insufficient; Runoff causing gulley erosion on the northeast corner of the Location; slopes along western end of the Location bare/exposed; degradation evident.

Corrective Action: Comply with Rule 1002.f.(2)C and install required stormwater and erosion control BMPs; ensure control measures are adequate for the site's conditions, installed in accordance with good engineering practices, and are maintained in a proper functioning condition.
