During this inspection the following possible compliance issues were observed: Stained soil around wellheads needs to be removed. "Properly dispose of oily waste in accordance with 905.e." With a corrective action date of 3/19/21. Appears to be leaking Master Valves. Securely fasten all valves, pipes, and fittings to ensure good mechanical condition, inspect at regular intervals and maintain in good mechanical condition per Rule 608.e. With a corrective action date of 3/19/21. Trash in multiple spots on location needs to be removed for good housekeeping. Comply with Rule 606. With a corrective action date of 3/19/21. Inadequate wildlife protection (bird protector) is off of the pit. Install wildlife protection equipment. With a corrective action date of 9/22/20.
