During this inspection the following possible compliance issues were observed:

Location is in close proximity of Parachute creek and in a High Priority Habitat Area. (Mule Deer Winter Concentration Area, Elk Winter Concentration Area)

Unmarked deadman on location.

Erosion rill from channel in perimeter berm. Berm is poorly compacted. Perimeter ditch needs maintained. Rilling from location running along ditch on access road. Location shows signs of lack of stabilization BMP's in some areas (rutting is present). No evidence of tracking control BMP's.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
