Foundation has performed final reclamation at the well location, access road and the southern flowline area.

Operator has performed final reclamation activities, with the evidence of drill rows and straw crimped mulch. Straw crimped mulch has blown off areas, which may require additional BMP maintenance and implementation. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1004.
