On 2-18-2021, I attempted to make contact with the complainant who indicated that on 2-10-2021 Witnessing a man performing work on the Dacono facility emitting a mist of toxic smelling chemical form the well storage tanks. I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any unusual odor. I spoke with KPK representative he stated the pumper was draining separator and fuel pot. This is part of maintenance. Weather conditions: Clear No violation of COGCC rules were observed at the time of the inspection.
