Dear Director Murphy:

In accordance with Rule 218.b.(1-7) Transfer of Operatorship Intent, Valkyrie Operating LLC (Valkyrie), Selling Operator, would like to inform Colorado Oil and Gas Conservation Commission (COGCC) that Valkyrie will be transferring select assets to Buying Operator Impetro Resources LLC (Impetro). The transaction is to be considered confidential and any other associated information confidential pursuant to § 24-72-204(3)(a)(IV), C.R.S. In lieu of a Form 9 Intent and Subsequent, Valkyrie and Impetro submit this letter of attestation and associated documents to notify the COGCC of the transfer of assets.

Per Rule 218.a.(1) Included as Attachment A is Transferable Items associated with this transaction. Both Operators agree to the transfer of operatorship of the attached list of Transferable Items and that the attached list of Transferable Items is complete. Additionally, included as Attachment B, are the Items Not Transferring with the acquisition.

Impetro believes it has adequate financial assurance necessary for this transaction per Rule 703. The transfer of assets was final February 8, 2021. Impetro will be assuming responsibility for all Transferrable Items associated in this transaction. Any Items not transferring in this transaction will remain the liability of Valkyrie and Valkyrie will retain compliance with Commission rules.
