**General Comment:**

Inspector driving on CO State Hwy 13 north and noticed black smoke and flames coming from the location. Inspector immediately drove to location and observed combustor with open flames and burning balls of fluid coming out of the top. Inspector called the emergency number listed on the entrance sign. The number went to the previous operator, Gulfport Energy, while the sign stated the operator was Puma Energy. After speaking with COGCC engineering inspector called Ben with Organic Energy and was speaking with Alan from TOC when Moffat County sheriff and fire response crew arrived on location. Emergency response had been called by the landowner. A pumper was sent from Meeker and emergency response stayed on location until the flames were extinguished and the well was shut in. Organic Energy submitted a Form 22 Incident Summary Document Number 402609078 on 2/24/2021.
