Comment: The cattle guard along the main road is filled in with sediment and is not maintained. There are areas along the main road where stormwater is not diverted toward the culvert which is creating vehicle rutting and pooling on the road. Areas of rutting along the road need to be repaired and properly stabilized. Previous corrective action was not performed. Corrective action needs to be performed immediately to obtain compliance. Additionally, there is vehicle rutting west of the well site where the drip line is located.
