Detected gas bubbles in the cellar on RWSU well Larson MB C 11X25 (API: 0510307173). Gas is communicating through the bottom of the cellar in very small quantities. We plan to execute a remedial cement squeeze to mitigate this issue. We confirmed the leak on Feb. 24th, and plan to execute the mitigatory work to repair well as needed. A detailed wellwork plan and wellbore diagram are attached.
