Reinspection, passed, 3 corrective actions-access road was maintained, stuffing box oil under fencing removed but still oil stained soil under stuffing box, animal holes in berms are back.

Stained soils at wellhead, pit berms on south side are eroding into pasture and down the hill with an erosion rill forming on SE corner of pasture just outside the pit fence. Leaking valve behind (north of) east 200 bbl tank. Remove free oil, removed stained soil inside berms and fix leaking tank valve.
