## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to provide prior notice of the plugging and abandonment of the Schmid 2-34 well and associated flowline. The flowline will be partially removed, and the remaining segment will be abandoned in place. In accordance with COGCC Rule 911.a., soil samples and a groundwater sample (if present) will be collected following excavation at the wellhead and following removal of the flowline to determine if soil and groundwater (if present) meet the concentration levels of COGCC Table 915-1. Field screening of soil will be conducted during sampling activities. Soil vapor screening will also be performed around the wellhead. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Following excavation at the wellhead and removal of the flowline, discrete grab soil samples will be collected from the excavation. The soil samples will be field screened for total volatile organic compounds using a photoionization detector (PID). If field screening does not indicate impacts to soil in the wellhead excavation, only the base soil sample will be submitted for laboratory analysis. If impacts to soil are observed in the wellhead excavation or in the flowline excavation, the soil samples exhibiting the highest degree of impact will be submitted for laboratory analysis. Soil samples that are submitted for laboratory analysis will be run for the full list of analytes for soil in Table 915-1. The proposed soil screening and sampling locations are depicted on Figures 2 and 3.

### Proposed Groundwater Sampling

If groundwater is encountered during wellhead and flowline excavation activities, a minimum of one grab sample will be collected from the excavation (if present) as soon as practical and submitted for laboratory analysis of the full list of analytes for groundwater in Table 915-1.

Following excavation at the wellhead, a maximum of five shallow soil vapor screening points will be installed around the wellhead. Two shallow soil vapor points will be installed in the base of the wellhead excavation, and three will be installed outside the extent of the proposed wellhead excavation. The proposed shallow soil vapor points are depicted on Figure 2.
