#### Other Potential Receptors within 1/4 mile

The South Platte River located ~ 300' to the N/E is a surface water feature within 1/4 mile of this location. The Aquatic Native Species Conservation Waters, CPW State Wildlife Areas and State Parks, and Mule Deer Severe Winter Range are all within the 1/4 mile buffer of this proposed active work area. The closest water well with a static water level recorded is DWR Receipt number 9061801, which is ~ 4325' to the W. The static water level is 28ft, but the elevation of this water well is ~ 10 ft higher, so there could potentially be groundwater within 20 feet of the surface at the North Platte 44-11-28HZ oil and gas location.

All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
