**General Comment:**

NOTE TO OPERATOR: During the process of review/research of COGCC/COGIS Database for Operator Information: Omimex Petroleum Inc. #66190, reason for contact attempts was for scheduling/confirmation/Form submission of 2021 UIC well inspections. Field Inspector (Schure) attempted telephone contact derived from information provided by Operator @ contact list on COGCC/COGIS Data Base.

Operator's main contact number listed as (720) 739-6127 failed (3) contact attempts indicating telephone number is no longer in service.

Emergency contact telephone number listed on COGCC/COGIS Data base (918) 625-1477, was called for verification and received by an answering mechanism, therefore Field Inspector Schure left a message to return the call immediately. Approximately (1) hour later, F.I. Schure received a return response from (918) 625-1477. Responding caller informed Schure that this telephone number is a private number and property of a former Omimex independant engineering consultant, respondant was unaware that this telephone number is cited on the Omimex data listing. Upon inquiry from F.I. Schure the respondant @ (918) 625-1477 stated that he had not been associated with Omimex Petroleum Inc. since approximately October of 2020. This Emergency Contact Number is invalid.

Field Inspector Schure reviewed/researched Emergency Contact information offered from previous F.I.R's on Omimex Petroleum Inc. well signage as (877)425-4822. (3) attempts at reaching Emergency Contact at (877) 425-4822 indicated number is no longer in service. Emergency Contact information on signage at well-site is invalid.

Field Inspector Schure, then called Mr. Jeremy Fisher @ (970) 854-4377. Mr. Fisher is an independant contract field manager associated with Omimex Petroleum Inc, Mr. Fisher answered the phone on the first attempt and confirmed that the 2021 UIC wells are prepared for inspection and scheduling of COGCC UIC inspections for (6) UIC wells was confirmed, pending Form 42 notification from Operator.

Review/research of Production Reporting on this well and (5) other randomly selected Omimex Petroleum Inc. wells indicate last date of production/injection reporting as 8/1/2020. Indicating Production Reporting from Operator is (6) months past due. Contact COGCC Engineering Supervisor (Diana Burn) for directives/requirements related to production reporting.

Field Inspector Schure contacted N.E. Field Inspection Supervisor (Craig Quint) for directives. Mr. Quint offered assistance with issues/concerns and scheduled a telephone conference/update with Schure on Monday, March 29, 2021. Mr. Quint will lead investigation with assistance from Mr. Schure going forward. COGCC Compliance Manager (Mike Leonard) and COGCC Engineering Superviso (Diana Burn) will be notified of issues/concerns via FIR Doc #699602317.
