Corrective Action:	<p>Comply with Rule 1004.a and conduct final reclamation including, but not limited to, removal of anchors and remaining pipe from the location, recontouring/regrading, compaction alleviation and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.</p>	Date 06/01/2016
