## INITIAL ACTION SUMMARY

On October 28, 2016, site investigation activities were conducted to assess the potential presence of petroleum hydrocarbon impact associated with two historical evaporation pits and one adjacent tinhorn. Please refer to the LTE Site Investigation and Closure Request, dated December 29, 2016, for additional details.

Six soil samples were collected from within the pits to evaluate potential hydrocarbon and inorganic impacts to the site. All six soil samples were analyzed for BTEX, and one was analyzed for EC, pH, and SAR. To evaluate background conditions at the site, a total of ten soil samples were collected from five background locations. One sample was collected from 1 foot below ground surface (bgs) and one from 3 feet bgs from each location. The samples were analyzed for EC, pH, and SAR. Ten soil samples (one foot bgs and 3 feet bgs at each location) were collected from five locations at the site to evaluate background conditions. EC results ranged from 0.84 to 9.26. The highest EC results from the six pit samples was 6.72 between 0 and 3 feet bgs, which is less than the highest background level.

Per the Condition of Approvals (COA) issued by the COGCC on March 21, 2017 (Document # 401206319), supplemental confirmation soil sampling will be conducted adjacent to and within the former pit location to confirm that reclamation was successfully completed by the former operator of this location. Fourteen soil borings will be advanced to approximately 3 feet below ground surface to confirm that inorganic impacted material was buried below 3 feet bgs during reclamation activities. Two soil samples will be collected from each soil boring at approximately 1 foot and 3 feet bgs within the reclaimed area to confirm that backfill material used for reclamation exhibits inorganic levels within Table 915-1 standards. The samples will be submitted for laboratory analysis of electrical conductivity, pH, and sodium adsorption ratio (SAR) using the saturated paste method. Analytical results and a photo log and summary of field activities will be provided to illustrate and document the current reclamation status of this location. The proposed soil boring locations are illustrated on Figure 1.
