Comment:

Form 6(s) states well was PA 10/14/2019; pursuant with Rule 1004.a, all surface equipment required to be removed by 1/14/2020, and all final reclamation activities required to be completed by 10/14/2020.

It was observed in this inspection that final reclamation has not been conducted in accordance with 1004 rules; surface equipment remains on the Location. Adequate seeding activities does not appear to have been performed; location remains bare and exposed soils, desirable vegetative germination not observed; control measures to stabilize seeded soil missing or insufficient; wattle BMPs not maintained in proper functioning condition and is now debris and requires removal.

Corrective Action:

Comply with COGCC 1004 Rules and conduct reclamation on the Location including, but not limited to, removal of surface equipment and debris, compaction alleviation and revegetation activities. Ensure control measures are implemented to stabilize the seeded soil. Continue to monitor and manage Location for reclamation, stormwater and weed management until site receives a passing final inspection.
