CIBP set at 6529' topped with 2 sxs of cement and pressure tested to 2000 PSI for 15 Minutes for PDC's Bath-Schmier offset Fracs. An MIT was completed 3/25/2019 and pressure held all documents submitted to COGCC. Surface equipment has not been removed from the location. PDC intends to return this well to production once the offset frac is complete and requests continued TA status.
