Comment:

This location does not comply with Rule 1004. Equipment remains at the associated tank battery. Also, the tank battery area does not have establishment of winter wheat which is not reflective of reference areas. After all equipment has been removed, Operator may have to perform additional reclamation activities. Refer to the attached inspection photos.

Based on visual observations and drone imagery, it appears the well location access road and well location are reflective of reference crop areas.

Corrective Action:

Comply with Rule 1004 to remove (regardless of ownership) all equipment at the tank battery. All equipment should have been removed within three months of plugging (04/27/2020).
