**Environmental****Spill/Remediation:**

Comment: COGCC Environmental Staff confirmed offsite impacts related to a release of hydrocarbons from the ECD and/or flare. Pursuant to Rule 912.b.(1)H. Spill or Release resulting in vaporized hydrocarbon mists that leave the Oil and Gas Location or Off-Location Flowline right of way from an Oil and Gas Location and impacts or threatens to impact off-location property is a reportable release.

Corrective Action: Operator will report release on a Form 19 Initial and Supplemental Reports as required in Rule 912.b. Location is in a High Priority Habitat for Pronghorn Winter Concentration - Operator to report spill to CPW concurrent with submittal of Form 19 - Initial. Operator to initiate cleanup of impacts on and offsite and collect confirmation soil samples for analysis of Table 915-1 Organics in Soil and TPH (C6-C36). Operator to coordinate remediation of offsite impacts with Surface Owner. Corrective Action Date is date Form 19 Initial was due (72 hours from discovery)
