While there, I observed normal production operations.  
During this inspection the following possible compliance issues were observed:

- 1) Battery sign weathered and not legible. See Photo #3467 with a corrective action date of 7/13/21.
- 2) Location lacks stabilization. See photo #3468 and #3469. No form of tracking control at entrance to location. See photo #3470 with a corrective action date of 4/28/21.

- Location is located on the edge of a high priority habitat area.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules.
