Nearest existing or permitted wellbore belonging to another operator is the Shoveler Goldeneye Fed #21-16-1HN, API 05-123-47027 (MALLARD EXPLORATION LLC), measured using 2D manual calculations. The distance is 555'.

This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 300' FSL and 988' FEL of Section 20. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.
